In accordance with the Proceeds of Crime and Anti-Money Laundering Act, 2009 (AML) legislation there is an obligation to undertake Enhanced Customer Due Diligence (ECDD) on those clients who are classified as a Politically Exposed Person (PEP).

- **D** prominent public function including:
- □ head of state, head of Government, Government minister, deputy or assistant Government minister;
- □ a member of parliament;
- □ a member of a supreme court, constitutional court or other high level judicial body whose decisions, other than in exceptional circumstances, are not subject to further appeal;
- a member of a court of auditors or the board of a central bank;
- an ambassador, chargé d'affairs or high-ranking officer in the armed forces;
- □ is a member of the administrative, management, or supervisory body of a state-owned enterprise.
